Thank you for your interest in participating in the Lake Shelbyville Muskie Club Open Fall Tournament on Sunday, September 21, 2008. This tournament will be a one day event. The tournament will start at the boat ramp in Eagle Creek State Park. When arriving at the ramp site, make sure you check in at tournament headquarters, which will be at the southeast end of the parking lot. Upon checking in, you will receive a registration packet, including release forms and equipment. Be sure to read all of the tournament rules. Some rules have changed since last year. Any questions regarding the tournament rules, which are included in this packet, should be asked when checking in.

**There are two new mandatory rules that affect where you will be allowed to fish**

- **No fishing will be allowed in the "No Wake" zones at The Lithia Springs Marina and the Findlay Marina. These areas are off limits to both casting and trolling .**
- **The "100 foot rule" will be enforced. If you serve as a witness to a fish caught by another team, you must move at least 100 feet from their boat before starting to fish again. If you are in a small cove, and you witness a fish for another team, moving over to the other side of the cove is acceptable.**

The tournament fee is \$40 per person or \$80 per team. Checks should be made out to the Lake Shelbyville Muskie Club. To register for the tournament, complete and sign the registration form below, **also, read and sign the Liability Form on the back of this page.** (Once a Liability Form is signed and submitted, it is good for the whole year.) I am familiar with other risks up to and including death by drowning associated with rough water; changing weather conditions, heavy winds and lightning storms. I expressly assume all risks associated with this tournament and I hereby release LAKE SHELBYVILLE MUSKIE CLUB, the host, sponsors and tournament officials from all claims of negligence resulting from injury and/or property damages incurred in connection with the tournament.

2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my participation; and

3. I will comply with all rules and regulations. If I have any questions, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official; and

4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify and hold harmless LAKE SHELBYVILLE MUSKIE CLUB, the owners and lessors of premises used to conduct the tournament, their officers, officials, ("Releasees"), with respect to any and all injury, disability, death, of loss of damage to person or property, whether caused by the negligence of the Releasees or otherwise, to the fullest extent permitted by law.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
